## Minutes of the Regular Farmington City Council Meeting July 11, 2016

The regular meeting of the Farmington City Council scheduled for Monday July 11, 2016 was called to order at 6:00 pm by Mayor Ernie Penn. Approval of the minutes for the June 13, 2016 regular meeting of the city council.

**Semi Annual report on Ozark Regional public transit in Farmington** – Jeff Hatley gave a short report to the council regarding the record year participation for the Farmington route. There was a 17% increase in ridership and a 23% increase in para-transit ridership.

## Ordinance 2016-04 An Ordinance waiving requirements of competitive bidding for the purchase of an HD audio/video system for Farmington City Hall pursuant to Ark. Code Annotated 14-58-303 (b) (2) (B)

A motion was made by Alderman Mathews and seconded by Alderman Pike to suspend the rule requiring the reading of an ordinance in full on 3 different dates be suspended and that ordinance 2016-04 is to be read by title only one time. It was approved by all those present. City Clerk Penn read Ordinance 2016-04 by title only. Mayor Penn asked shall the Ordinance Pass? It was approved by all those present. A motion was made to approve the Emergency Clause by Alderman Mathews and seconded by Alderman Parsley, it was approved by all those present.

## Request Approval of bid form Commercial Audio Systems for HD video control system.

On the motion of Alderman Bryant and seconded by Alderman Parsley and by the consent of all members present, the motion was approved to accept the bid from Commercial Audio Systems as presented in the amount of \$39,726.23 and add the document scanner/display and wireless, the additions cost not to exceed \$2000.00, for a total purchase price of \$41,726.23 plus any applicable sales tax.
